RELEASE AGREEMENT

I, the undersigned, individually and as the parent or guardian of _____, (collectively the "Releasor"), and in consideration of such child being permitted to participate in the junior golf program and related activities, hereby release, waive, discharge, and covenant not to sue Scotland Run Golf Club, Inc., its related entities, owners, officers, directors or employees, (collectively referred to as the "Releasee"), from all liability to the Releasor, his personal representatives, assigns, heirs and next of kin for all loss of damage, any claim or damage therefore, on account of injury to the child or his or her property or resulting in death of the child, whether caused by the negligence of Releasees or otherwise while the child is participating in the junior golf school program and related activities. Releasor further hereby agrees to indemnify the Releasee from any loss, liability, damage or other costs Releasee may incur due to the presence of the child in or about the Scotland Run Golf Course whether caused by the negligence of Releasee or otherwise. Releasor assumes full responsibility for the risk of bodily injury, death or property damage to the child due to the negligence of Releasee or otherwise while the child is in or on the Scotland Run Golf Course and/or while participating in the junior golf program and related activities. Releasor agrees that this release, waiver, indemnity are intended to be as broad and inclusive as permitted by the laws of the State of New Jersey and that if any portion herein is held invalid, that the remaining provisions shall, notwithstanding, continue in full legal force and effect.
